# Farm-Gate Pickup

The Egg Farmers of Alberta (EFA) Board of Directors is pleased to report that we are in active communication with Alberta egg graders about the issue of farm-gate pickup. Both sides are engaged in a respectful and productive manner and are hopeful that a resolution will be reached soon. The graders have assured EFA that they will be picking up eggs and no eggs will be left on the farm.

EFA will continue to keep Alberta egg farmers updated as the discussion about farm-gate pickup progresses.

# Retail Council of Canada

EFA was thrilled by the Retail Council of Canada's (RCC) recent announcement that they will no longer pursue their voluntary 2016 commitments to source only cage-free eggs by the end of 2025. Instead, the RCC has shifted their focus to the advancement of animal welfare in Canada through the National Farm Animal Care Council (NFACC) and their Codes of Practice. It will, however, remain up to individual RCC members to make independent decisions about their sourcing practices.

# Biosecurity Assessments 2021 - Quarter One Update

From January to March 2021 EFA's Field Coordinators have been able to conduct 111 biosecurity assessments. Alberta egg producers have been working hard to improve their primary property signage. Currently, there is an increase in the number of signs with the following information: biosecurity, contact information, and trespassing/private property.

EFA is also encouraging producers to hang signs that indicate where their transition line to the restricted zone is. # Poultry Diagnostics Update

The Alberta Poultry Industry (API) comprised of Alberta Chicken Producers, Alberta Hatching Egg Producers, Alberta Turkey Producers, and Egg Farmers of Alberta has reached an agreement in principle with the University of Calgary's Faculty of Veterinary Medicine (UCVM) as the industry's new partner for poultry diagnostics in Alberta. We are excited about this new era of strategic partnership in poultry diagnostics, which is the culmination of more than two years of effort by the joint poultry diagnostics committee.

We extend our thanks to Poultry Health Services (PHS) for their years of excellent diagnostic services for the poultry industry. We recognize the contributions their team has made over many years and wish them continued success.

We believe that diagnostics at the UCVM will provide tremendous value for the Alberta poultry industry. Diagnostic services are the priority for this partnership, however collaborating with a world class university will also offer unique opportunities for teaching the next generation of poultry practitioners and diagnosticians, as well as research opportunities for improving poultry health.

We recognize and respect each producer's ability to select their own poultry practitioner. We sincerely hope that the UCVM's DSU will become your choice for poultry diagnostics.

The UCVM currently has pathologists on staff with poultry experience, and they will also be recruiting a boarded poultry pathologist in the near future.



# Update on SE Recall Mitigation Strategy

The Egg Farmers of Canada (EFC) National Salmonella Enteritidis (SE) Protocol sets the minimum standards for the sampling process and the management of SE positive environments in all regulated layer and pullets farms in Canada. This protocol, which has been in place since 1997, draws on a preventative approach to ensure eggs sourced from an SE positive environment do not reach the table market. While this national and proactive approach to



managing SE in the egg farming sector has successfully negated recalls for over two decades, the CFIA has recently stated that a positive environmental SE test will result in an egg recall back to the date of the test.

Given these circumstances, and with the goal of minimizing the risk of product recalls and the accompanying financial burden and reputational issues, Egg Farmers of Canada has identified a number of strategies to advocate for the sector and work towards an industry-wide solution. This approach was developed in consultation with all provinces and the graders via the Canadian Poultry and Egg Processors Council (CPEPC).

A key component of the strategy is a national task force and ongoing outreach to the CFIA and Health Canada. Additionally, provinces across Canada are working to implement a system whereby Salmonella test results are received prior to the producer's next scheduled egg pick-up. This is a significant undertaking.

EFA has implemented an overnight sample shipment process and revamped testing schedules to align with egg pickup dates. We thank farmers for their flexibility and understanding as the farm visit now needs to happen on a very specific day. These actions shorten the time from swab at the farm to arrival at the lab and increase the amount of time available to receive results.

EFA is working closely with the Government of Alberta to revise protocols to reduce the time from receipt at the lab to release of results, but the situation is complex. We are actively monitoring turnaround times and will be working on continuous improvement in the coming weeks as we start to see if we are meeting our target.

If you do not have test results back before your next scheduled egg pick up date, please communicate with your grader on next steps. It is our understanding that in some cases the eggs may be left on farm (with additional supplies provided) and in other situations eggs may be shipped to the grading station and held. The Purchase and Sale of Eggs and Egg Product Regulation governed by the Province requires graders to provide a copy of the grade-out to the producer within 14 days of receiving the producer's eggs.

We understand this is a frustrating situation for farmers. We continue to work collaboratively and nationally to come up with a better solution. In the meantime, we appreciate your support and efforts as we do our best to avoid costly and damaging recalls.





# Movement Tracing Engagement Webinar

Thanks to all those who participated in EFA's Movement Tracing Webinar on March 18th.

The zoom meeting was attended by over 40 registered producers as well as EFA staff and representatives from hatcheries and grading stations. Dr. Sandra Stephens of the CFIA also attended to present and participate.



A summary of the meeting is available in a 'What was Heard' report that has been posted on the producer website at Healthy Farms (Movement Tracing). The edited video recording of the webinar will be posted in the same location in the coming weeks. Key learnings included:

- To stop the spread of highly contagious diseases, we must stop movement until we know where it went and how. There is a tradeoff: The more we do upfront to ensure our ability to trace quickly and accurately, the less movement controls we will have and the shorter they will be.
- While many farmers believe the status quo (paper logbooks) are the best solution, there is also an understanding about the limitations of such a system.
- There is support for electronic options, but privacy concerns must be addressed, and the risks must be properly mitigated.
- For options which may move forward EFA needs to investigate, and clearly articulate, how it would work for those without a smart phone.

In a follow-up survey, participants communicated that the webinar provided good background on what EFA is trying to achieve (average rating of 4.4/5) and provided good opportunity for input (average rating of 4.4/5).

# Safety Minute from AgSafe Alberta

Congratulations for getting started with safety on your farm. Your efforts make a difference even though you may not always see it.

Did you know in the Alberta poultry industry falls are the most frequent injury? The injuries from these falls take an average of 17 days to recover. The body parts most injured are the head and the trunk.

While it is possible that these are from heights, it may be more likely that they are on the same level. Do you take time to ensure that items get put away? Is there a place in your barn where levels change that could be fixed or identified better to reduce the chance of a fall? Take some time to identify areas on your farm where falls could happen and what can be done to reduce the chance that a fall happens. Make sure you communicate this to everyone who works in the area as well, they may also help identify areas where falls can happen when you include them in the process.

# CPTPP Mitigation Update

As a follow-up to the Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP) Mitigation updates shared in the February 2021 and December 2020 issues of EggNotes, EFA is thrilled to announce the launch of the Poultry and Egg On-Farm Investment Program (PEFIP). This announcement comes after several months of negotiations between Agriculture and Agri-Food Canada (AAFC) and the national SM4 (Egg Farmers of Canada, Chicken Farmers of Canada, Canadian Hatching Egg Producers, and Turkey Farmers of Canada).

The Government of Canada announced \$691 million of mitigation funding for the egg and poultry sector on November 28, 2020, to offset the impact of market losses caused by the CPTPP. The PEFIP was developed to ensure the funding goes directly back to Canadian farmers. The PEFIP has allotted the \$691 million across the supply managed egg and poultry industries as follows: Eggs (\$134.00 million), Chicken (\$347.28 million), Hatching Eggs (\$88.57 million), Turkey (\$59.61 million).
