Board Update



Your Egg Farmers of Alberta (EFA) Board of Directors are pleased to announce that after considering many potential modifications, ranging from minor tweaks to major changes, the Board has adopted revisions to EFA's Quota Exchange based on feedback from the Quota Exchange Survey. The modifications are minor, but the Board feels they benefit the producers engaged in the Quota Exchange. The process for submitting applications to sell and purchase quota remains unchanged. The Board would like to thank producers for their ongoing engagement in this program and all the feedback and suggestions in the recent producer survey.

The Board will review the proposed changes to the Quota Exchange through a consulting firm that will verify their effectiveness. Once the modifications have been validated, EFA will take the opportunity to update producers on the modifications to the Quota Exchange at the Regional Meetings in January 2023.

The Board plans to go live with the Quota Exchange modifications upon QE-2 2023's launch.

The EFA Board is also pleased to announce that Egg Farmers of Canada (EFC) has redistributed a portion of the funds collected from producers for Service Fee contributions. Service Fee was collected from producers between 2014-2020. EFA will be redistributing the funds to producers relative to the amount each producer paid into Service Fee during that time. In total, EFA will redistribute nearly \$1.6 million back to producers who contributed to Service Fee. Producers can expect to receive their refund on February 24, 2023.

Continuing the thread of good news stories, January 2023 will bring a new allocation of quota from EFC to the provinces. In total, the Board will be increasing our provincial quota allocation by 80,233 in 2023. This allocation will also trigger the New Entrant program in 2024.

The Board would also like to wish everyone a Merry Christmas and a Happy New Year, as we head into the holiday season. Please stay safe and keep warm. See you all in 2023!











Avian Influenza (AI) Update

As of the time of publication, there are currently 8 active Primary Control Zones (PCZs) in the province, with 60 total confirmed cases (33 commercial poultry farms + 1 commercial mixed poultry farm).

Since mid-November BC has experienced over 50 cases of AI on commercial poultry operations. This continues to strain resources in Western Canada and demonstrate the continued presence of the virus. Our thoughts are with our friends and colleagues in BC as they deal with the stress and challenges associated with this fall/winter outbreak. We will continue to support them wherever possible.

There is lots new this month in poultry research! We would like to start off by letting you know the producer portal has been updated with video presentations on research projects, Beak blunting in laying hens using a modified feeder and Infectious Laryngotracheitis in backyard poultry and what this means for the commercial poultry industry.

The portal has also been updated with several research summaries from Egg Farmers of Canada and the Canadian Poultry Research Council including the Effects of Maternal Stress on Layers, How Aviary Rearing systems affect Fearfulness in Pullets, Keel Bone Health, and Aviary Rearing Systems Building Better Bones and Muscles. Additionally, a meeting summary and technology transfer information from Poultry Innovation Partnership's Spark 2.0 meeting on October 17th has also been added.

On August 8, 2022, producers received a memo outlining the timelines and records that would be changing with the launch of the Revised Animal Care Program. On the producer portal the updates stand alone fillable pdf records to reflect the Revised Animal Care Program have been loaded.



These include the following documents:

- · Farm Animal Welfare Policy
- Employee Code of Conduct Policy
- · Beak Treatment and Trimming Policy
- Vaccination Record

- · Handling, Catching, Loading Guidelines
- · Catching Crew Record
- Euthanasia Training Records
- · Individual Bird Euthanasia Plan
- On-Farm Depopulation Euthanasia Plan
- Emergency On-Farm Depopulation Euthanasia Plan

As well as updated Standard Operating Procedures for Individual bird and Depopulation Euthanasia that include veterinarian signatures.

Please ensure that you are using these updated resources as you prepare for your upcoming Animal Care Program audits in 2023.









From Your PMC: Highly Pathogenic Avian Influenza Prepardness Package

As we head into the winter season, producers continue to remain concerned about the looming risk of Highly Pathogenic Avian Influenza (HPAI). During the last Production Management Committee (PMC) meeting, members reviewed several template Standard Operating Procedures (SOP) for Disposal and Cleaning and Disinfecting pertaining to HPAI.

To accompany these SOPs a Disposal working group comprised of members of the Alberta Poultry Industry Emergency Management Team (APIEMT) have been working to develop a decision tree to walk producers through their disposal options, a document to review legal landsites and setback requirements, and the process for contacting Alberta Agriculture and Irrigation (AAI) to get provincial approval for burial sites.

The delivery and review of all these resources (SOPs, decision tree, burial site requirements etc.) will be presented in an upcoming webinar in the New Year titled, What to Expect if You're Avian Influenza Positive.

The PMC would like to stress the importance of preparedness to producers. It is important to take as many proactive steps as possible including attending the webinar, completing the templates, and having a plan (and backup plan) in place. During a disease outbreak it is in the industry's best interest to move quickly and efficiently. The more a producer can do to prepare themselves for the outcomes of a potential disease detection the more effective the response and timeliness of activities and the less stress on you!

Stay tuned in the new year as additional details on the HPAI webinar and package are released.

Disposal Services – West Coast Reduction Ltd.

In 2019 EFA advised Alberta egg farmers that West Coast Reduction Ltd. (WCRL) (formerly Northern Alberta Processors) was terminating their depopulation (MAC cart) service for farmers in Alberta. At that time, it was noted that WCRL would continue to provide collection and recycling of spent hens and would adjust their rates to reflect this change in service.

For those farmers who continued to use WCRL for spent hen disposal we would like to advise that as of November, 2022 WCRL has limited capacity to receive birds and has told some farms they are not accepting spent fowl. If you rely on WCRL to receive your birds post-depopulation, we recommend you connect with them regarding capacity during your scheduled timeframe and consider alternative methods of disposal if necessary.



Changes to Special Programs Lease Policy

Effective as of November 2022, there are changes to the Special Programs Lease Policy:

- Producers don't qualify if they are naturally shifting months based on an extended flock cycle (ex. if recent flocks show a history of being in lay for more than 52 weeks).
- The 5% for movement to January is staggered at 2% in the 1st year, 5% in the 2nd year, and 8% in the 3rd year (total of 15% to match with 5% for 3 years)
- The 2% for movement to May is staggered with 1% in the 1st year, 2% in the 2nd year, and 3% in the 3rd year (total of 6% to match with 2% for 3 years)

The goal of the above staggering is to incentivize producers not only to change, but to stick with the revised schedule when there may be competing incentives to switch back.

As a reminder, Egg Farmers of Alberta has established a pool of 10,000 layers to be used for special programs that encourage the adoption of good management practices and production efficiencies. Two production practices have been targeted for special programs due to the positive impact changes in these areas will have on the industry including moving to an all-in all-out production cycle and adjusting flock placement to periods of lower demand (ex. January, May) from periods of high demand (ex. March, April, October, November, December).

Special program leases are available on a first come, first serve basis to those who submit a completed application form and meet application requirements.

Farms are loud places, but how loud is too loud? Article written by Jody Wacowich, AqSafe Alberta

Noise induced hearing loss is a common problem among farmers. Hearing loss in adult farmers is almost double that of non-farmers.

Damage that occurs from noise exposure is gradual and it sneaks up on you. The higher the noise level the shorter the exposure time that is required to cause the loss. Noise induced hearing loss is irreversible, but the good news is that it is preventable.

Noise hazards on the farm include:

- Tractors
- Clamouring of equipment or materials
- Compressors
- Tools (chainsaws, pneumatic tools)

If we have to start raising our voice to speak to someone about 1 meter away, then this noise could be hazardous to our health. There are apps that you can download, to give you an estimate of the noise levels you are working with (Note: because they are not calibrated, they are not considered an exact measurement). Sounds over 85 decibels cause hearing damage after 8 hours of exposure. An increase to 88 decibels reduces that time to 4 hours and at 100 decibels it is less than 15 minutes.

What can you do to prevent hearing loss?

Anticipate when you will be working in a noisy area and use the appropriate hearing protection. Often, we think about this after we get started, and it is too much time to go get it. So, identifying the hazard before we start helps us start the task with proper hearing protection. Remember, not all hearing protection is equal and not all hearing protection fits people the same way.

Factors to consider when selecting hearing protection:

- Is it comfortable?
- Are you wearing it correctly?
- · Are you wearing it when you should be wearing it?

NRR = Noise reduction rating. This is found on the box and the higher the number the better the protection.

Signs you may be experiencing hearing loss:

- Asking people to repeat themselves
- People saying—did you not hear me when I said
- Feeling like people around you are mumbling

I want to leave you with one last thought, think of an activity that brings a smile to your face, you can hear the sounds happening at that activity. What would that activity feel like if you could not hear it? Take a moment to grab some hearing protection before starting a noisy task.
